We lost 13 this past year, with only 4 new and another 9 starting the academy in February. We are also promoting within the department to fill positions. A few members of the staff and I also went to the factory to see the new ladder truck that was approved late last year. It should be delivered in December 2023. Chief Stone expressed his appreciation for the committee's support.
